- 9. Service provider profile while being viewed from employer doesn't show complete data. Skills missing.

One of our most important topics was messaging between Employer and Provider. We decided:

- 1. We should use the term messaging/messages instead of Chat. We don't want to convey that it will be live back and forth.
- 2. Providers should only be able to send messages to facilities once they have applied for a specific job under that Facility
- 3. Messages back from Facility should not provide personal information (name, picture, number, etc.) of the person responding, but should reflect the information of the Facility (name)
- 4. We need to ensure the messages are recorded and stored and available for review by Scalpel Connect Admins

Please find below the **Minutes of the Meeting** for the test session held today, **May 13th, 2025**, regarding the **Employer Side Profile Signu** and associated functional review across mobile and web platforms:

1. Mobile App - Employer Profile Signup

• TIN Number Validation Issue:

During the signup process for the Employer profile, the TIN number field currently accepts only 9 digits. However, the validation logi expects 10 to 20 digits.

Action Required: Align the input field to accept the correct validation range (10-20 digits) to prevent blocking user progress.

• Incorrect Profile Redirection:

If the app goes into the background during Employer profile creation and the user returns, it incorrectly redirects to the **Provider Profile** instead of resuming or showing the **Employer Profile**.

Action Required: Ensure correct session handling to maintain context when the app resumes.

2. Web Portal - Facility and Profile Section

• Facility Picture Sizing:

The uploaded facility images currently appear cropped or improperly aligned.

Action Required: Confirm and implement a preferred image dimension/ratio for optimal fit-to-screen display.

• Facility Not Shown After Signup:

On selecting the 'Facility' section from both 'My Profile' and the side menu, the facility added during signup does not appear on fi load. It becomes visible only after a hard refresh.

Action Required: Fix initial load issue to display facility details immediately post-signup.

• Image File Type Error on Edit:

Although **JFIF** image files are accepted during onboarding, an error is thrown when editing the facility description later — stating the only JPG, PNG, and SVG formats are allowed.

Action Required: Extend file type validation on the edit screen to include JFIF, ensuring consistency.

• Popup Dismissal Issue:

While creating a job, if the user clicks outside the popup unintentionally, all entered data is lost.

Action Required: Implement data persistence or a warning before closing the popup to avoid data loss.

Calendar View in Job Details:

Employers currently do not see a visual calendar view of the **dates** selected during job creation. They can only see the Est start & end dates.

Action Required: Display a calendar component (similar to what providers see) on the job detail screen for clarity, where we have information, facility, benifits, (Same as Calendar)

4. Contracts Section (For Next Meeting)

Attachment Requirement in Contracts:

It was highlighted that the contract functionality may require an attachment upload feature.

Action Required: Schedule this discussion in the next session to finalize requirements and feasibility.
